Your personal data will be protected and processed in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/WE ("GDPR").

Your personal data will be processed for purposes of:

- a. marketing, on the basis of your consent (6 Article, item 6 (a) a) GDPR i.e. for e-mail contact, in order to present the offer and commercial terms and to send personalized information about FIBARO products and services;
- b. GDPR i.e. for e-mail contact, in order to present the offer and commercial terms and to send personalized information about Fibaro products and services; item 6 (a) (b) GDPR i.e. for the performance of the contract;

Your data will be processed only for the period necessary to achieve the purpose for which the data were collected or to comply with legal regulations, but not longer than until your resignation from the services provided within the Application Installer or until your consent is withdrawn, when the processing of your personal data takes place on the basis of the consent granted.

Your personal data may be transferred to entities processing them on our behalf, i.e. entities providing technical services (development and maintenance of IT systems and websites), providers of mass mailing services, hosting services and distributors cooperating with FIBARO.
